

## COPPER MOUNTAIN FOUNDATION SCHOLARSHIP AND CAREER GRANT PROGRAM

**ELIGIBILITY:** Open to original enrollees of The Tatitlek Corporation (TTC) and lineal descendants of original enrollees (by birth or adoption). Student must be enrolled in an accredited college, university or vocational school. Students must maintain a cumulative 2.0 G.P.A., or remain in good standing if the academic or training institution does not grade courses. Student must also reapply for funding for each school period.

**SCHOLARSHIPS:** Annual scholarships up to \$2,000 for tuition, fees, on-campus housing, books & materials will be available to students who maintain at least a 2.0 G.P.A. during their college or vocational careers. Funds are paid by Copper Mountain Foundation directly to the institution. Student must reapply for funding each school period. The maximum award is granted to full-time students, as defined by your college or program. Students attending less than full-time will receive a pro-rated amount.

- **Transcripts Required Each Term:** The student must provide unofficial transcripts to Copper Mountain Foundation each term showing a cumulative G.P.A. of 2.0 or higher or proof of good standing (for non-graded programs) to continue receiving funding.
- **Probationary Period:** If a current student's cumulative G.P.A. falls below a 2.0, or if he or she is placed on probation by a non-graded program, that student will have one term to bring his or her cumulative G.P.A. up to a 2.0. The student will not be eligible for funding until his or her cumulative G.P.A. is a 2.0 or higher.

**CAREER ENHANCEMENT GRANTS:** Up to \$1,000 per person per year will be granted to shareholders or legal descendants of shareholders who are enrolled in accredited short-term certificate or licensing classes. (Examples: HAZWOPER, 6-Pack, TCC employee qualification requirements). Funds are paid by Copper Mountain Foundation directly to the institution.

**HOW TO APPLY:** Complete the scholarship application and provide following documents with the application:

- Descendant Registration Form (if applying as a descendant and aren't recorded as a TTC descendant)
- Scholarship/Career Grant Application
- Unofficial College/Vocational School Transcripts
- Current Term Class List
- Enrollment Verification Certificate or Enrollment Verification Letter From Your University

**DEADLINES:** Student must submit an application for each school period. For semesters: applications must be received by August 31<sup>st</sup> and December 31<sup>st</sup>. For quarters and trimesters: applications must be received by August 31<sup>st</sup>, December 31<sup>st</sup> and February 28<sup>th</sup>. Copper Mountain Foundation does not provide reimbursements or retroactive funding.
